

## **Rental of Downhill Scooters**

Rules of use and contractual clauses



## **Regulation:**


- During the summer season, downhill scooters are only permitted on two marked routes (Savoleyres- La Tzoumaz and Les Ruinettes-Verbier). It is prohibited on all hiking trails as well as on the downhill bike trails of the Bikepark.
- Wearing a helmet is mandatory. A helmet is included in the rental price.
- The user must comply with road traffic rules and is subject to the Federal Road Traffic Act (LCR 741.01 OCR 741.11). He must drive on the right-hand side of the road, be able to brake within half the sight line and give priority to pedestrians.
- When stopped, THE USER must park at the side of the road/track in a clearly visible place.
- The USER should expect oncoming traffic on all marked trails (roads open to vehicles).
- The marked downhill routes are part of the road and path network and are therefore not particularly safe or monitored. Holes, irregularities, wet ground, etc. are to be expected.
- The scooter user must adapt his driving and speed to the terrain as well as to the conditions, to his own abilities and to other road users.
- The minimum age to use a scooter is 8 years (120 cm), for young people accompanied by an adult. The child must be able to brake.
- The minimum age to use a scooter alone is 14 years (for young people not accompanied by an adult);
- The scooter may only be used by one person. It is forbidden to ride a scooter with two people, including an adult with a child.
- In the event of an accident, the place where it occurs must be secured and first aid must be provided to the injured person. The rescue service can be alerted by calling 144 (OCVS) or 027 775 25 11 (Téléverbier central). The injured should not be left alone.
- The rental is to be paid in advance. An identity document is required as a deposit.

## **Contractual conditions:**

- The USER shall test the steering and braking and will notify staff before departing if the scooter is faulty or not properly maintained.
- The USER may ask for instructions from TVSA staff on how to use the scooter.
- The USER must be covered by their own accident and third-party liability insurance.
- The cost of any damage incurred through the improper use, theft or loss of the scooter is immediately charged to the USER at the hire location.
- The USER agrees to respect the rental period of 1 hour.
- By signing, the tenant confirms that he/she has read and understood the contractual conditions and agrees to comply with them and undertakes to respect them.
- The USER guarantees that the persons (minors) accompanying him / her are also informed of the rules.
